The Clerk read a letter from Paul and Michelle Harding requesting the Township Committee consider assigning a Tax Lien for 158 Three Bridge Road, Block 10 Lot 7 to them. They recently purchased the adjoining lot. The Tax Collector explained the two options open to the Township Committee for handling a Tax Lien assignment. After a brief discussion the Clerk was asked to send a letter to the Hardings explaining that all Township held Tax Liens would be put up at a public auction to be held in 2021, and that further information would be forthcoming.

The CFO reviewed the results of the Best Practices Inventory with the Township Committee. Based on the results, the Township's State Aid should not be impacted by the responses.

The Township discussed possible dates for the Close Out and Reorganization meetings. It was decided the Close-Out meeting would be held on December 30, 2020 at 5PM. The Reorganization meeting would be combined with the regular January meeting and held on January 5, 2020 at 5PM.

Seery introduced "RESOLUTION APPOINTING AN ASSISTANT TAX COLLECTOR" known as R-35-2020.

Seery moved that this Resolution be adopted, which motion was seconded by Meschi and adopted upon a call of the roll.

The Township discussed revisions to the current Retiree Benefits Program. The new changes would include the current qualifications of a minimum of 25 years of service and have reached the age of 65 and adding worked a minimum of 30 hours per week. Additionally, it would only cover the Municipal employee for secondary insurance and prescriptions. It would not cover a spouse nor reimburse the employee for the Medicare Insurance deducted from Social Security.
