After a brief discussion the Township Committee decided to hold their Close-Out meeting on December 27, 2023 at 7PM and the Reorganization meeting on January 3, 2024 at 7PM.

The Mayor opened the meeting to the public for comment. Residents David Garrison and Norma Jean Miller spoke regarding issues they were experiencing with an adjoining neighbor whose cattle and dogs were continuously out and disrupting the neighborhood. This has been an ongoing matter and will be handled by the Court System. The Zoning Officer will be sent to reinspect the fencing. Resident Lisa Bishop lodged a complaint against Committeeman Seery with what she felt was harassment against her family. Carley Melchert asked the Township Committee to put more pressure on the County of Salem regarding the Route 77/Glassboro Road (CR619) intersection. Several other residents concurred and asked if the State Police could place some kind of flashing sign to alert drivers to the intersection.

Zeck introduced the following resolution:

BE IT RESOLVED, by the Township Committee of the Township of Upper Pittsgrove that the public shall be excluded from the following portion of this meeting during which time the Township Committee will discuss a subject for which the general nature is Attorney-Client Privilege.
