Zeck moved that the approved bills listed on the "BILL PAYING LIST" as presented to the Committee be paid which motion was seconded by Bishop and adopted upon a call of the roll.

The Clerk read a letter dated March 6, 2023 from Fralinger Engineering stating a price of \$4,250 to perform the bi-annually Daretown Lake Dam inspection. Cimprich made a motion to enter into an agreement for Fralinger Engineering to perform the Daretown Lake Dam inspection and prepare and submit the report to the State at a cost of \$4,250. This motion was seconded by Zeck and adopted upon a call of the roll.

The Clerk read a letter from Fralinger Engineering dated December 23, 2022 proposing Engineering, Surveying, and Inspection/Contract Administration Services, Fitchhorn Road Section II Resurfacing, 2023 NJDOT Municipal Aid Funding Program at a cost of \$17,200. After a brief discussion, Brian Coles, Public Works Superintendent was asked to speak with Fralinger Engineering to see if their cost could be reduced. Zeck made a motion to approve the proposal, if no reduction was given, to ensure the project moves forward. This motion was seconded by Cimprich and adopted upon a call of the roll.

The Mayor opened the meeting to the public for comment. Resident Betty Coombs commended the Township Committee for working to keep the ambulance service viable for our Township. She asked what the proposed changes for the Route 77/Glassboro Road (CR619) intersection were. The Mayor advised her that this was only to endorse a Traffic study to determine what changes, if any were warranted. It also required a 25% cost agreement from the County of Salem before the study was started. Mrs. Coombs last question was regarding better, wider internet service to the residents. At this time the Mayor advised her that there were no options open to the Township. The Mayor closed the meeting to the public for comment.

Zeck asked if a portion of the Recreation budget could be spent on American flags to be displayed through Daretown, 10 flags and Monroeville, 10 flags. This would be done from Memorial Day until 4th of July at a cost of \$650-\$700. After a brief discussion Zeck made a motion to move forward with the expenditure of Recreation funds for this project. This motion was seconded by Bishop and adopted upon a call of the roll.
