Bishop moved that this ordinance be approved on first reading and that a copy of this ordinance be published in the *South Jersey Times* issue of June 12, 2020 together with a notice of its introduction and a public hearing to be held at the Township Hall on July 14, 2020 at 7:00PM. This motion was seconded by Meschi and adopted upon a call of the roll.
