Paul Forlenza, from the TRICO JIF Municipal Joint Insurance Fund, gave a presentation regarding the benefits the Township had being a member for thirty plus years and the benefits with enrolling for another three-year term.

The Mayor opened the Public Hearing for "AN ORDINANCE OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF UPPER PITTSBURGH AMENDING AND SUPPLEMENTING ORDINANCES 85-3, 2005-7 AND 2006-5 "HOUSING STANDARDS" OF THE CODE OF THE TOWNSHIP OF UPPER PITTSBURGH REGARDING CHANGING THE LANGUAGE TO RESALE CERTIFICATE AND RENTAL CERTIFICATE AND ADDING THE REQUIREMENT FOR INSPECTIONS OF LEAD-BASED PAINT IN CERTAIN RESIDENTIAL DWELLINGS" known as Ordinance 2024-17 at 7:31PM as advertised.

The Mayor read the Ordinance by title, stating that it had been published in *South Jersey Times* issue of June 18, 2024 as required.

After hearing no comments for or against this Ordinance, the Mayor declared the Public Hearing closed at 7:33PM.

Cimprich moved that this ordinance be finally adopted on second reading and that a notice of its adoption be published in the *South Jersey Times* issue of June 14, 2024. This motion was seconded by Zeck and adopted upon a call of the roll.

Cimprich moved that this Resolution be adopted, which motion was seconded by Zeck and adopted upon a call of the roll.

The Mayor opened the meeting to the public for comments. Resident Justin Rosenbaum asked the Township Committee to consider live streaming the meetings. The Mayor stated that they would take it under advisement. Resident Gail Caron requested the Township Committee send a Resolution to the County of Salem with regards to Glassboro Road. Specifically asking for speed limit signs to be posted, no passing zones be increased and restricting truck traffic. Resident Betty Coombs asked if the same could be done for Shirley Road. The Mayor stated that a Resolution would be prepared for next meeting requesting the County look into No Passing lanes and speed limit signs on Glassboro Road. As to the same for Shirley Road he stated that the Township Committee will start with Glassboro Road and go from there with requests.

There being no comments from the public and no further business the meeting was adjourned to meet at the call of the Mayor.
