## **ORDINANCE #2020-3**

## "AN ORDINANCE TO AMEND AN ORDINANCE ENTITLED 'AN ORDINANCE TO REGULATE TRAILERS AND TO LICENSE TRAILER CAMPS IN THE TOWNSHIP OF UPPER PITTSGROVE, COUNTY OF SALEM AND STATE OF NEW JERSEY AND TO PROVIDE PENALTIES FOR THE VIOLATION THEREOF"

BE IT ORDAINED by the Township Committee of the Township of Upper Pittsgrove, County of Salem and State of New Jersey and the authority of same as follows:

1. The title of an Ordinance of the Township of Upper Pittsgrove presently entitled "AN ORDINANCE TO AMEND AN ORDINANCE ENTITLED 'AN ORDINANCE TO REGULATE TRAILERS AND TO LICENSE TRAILER CAMPS IN THE TOWNSHIP OF UPPER PITTSGROVE, COUNTY OF SALEM AND STATE OF NEW JERSEY AND TO PROVIDE PENALTIES FOR THE VIOLATION THEREOF" is hereby amended to read "AN ORDINANCE TO AMEND AN ORDINANCE PROVIDING FOR PAD FEES WITHIN LICENSED TRAILER PARKS"

2. The above Ordinance at Section 4 entitled "FEES FOR LICENSE AND TRANSFER OF LICENSE", Subsection (c), is hereby amended to read as follows:

SECTION 4-(c) In addition to the license fee provided for herein, each licensee shall also pay to the Township the sum of Twenty Dollars (\$20.00) monthly for each mobile home space which is occupied in whole or in part for each succeeding month.

3. All Ordinances or parts of inconsistent herewith are repealed to the extent such inconsistency.

4. SECTION 13. EFFECT – This Ordinance shall take effect June 1, 2020 after publication and in accordance with the manner provided by law.
