

Upper Pittsgrove Township

January 2, 2020

The reorganization meeting of the Upper Pittsgrove Township Committee was held in the Township Hall on the above date.

The Committee members present were Jack R. Cimprich, Edward Meschi, Bruce W. Bishop, David A. Zeck, Sr. and Michael J. Seery, Sr.

The meeting was called to order at 7P.M. with the Clerk reading the public announcement stating that adequate notice had been given provided under the Open Public Meeting Act.

The newly elected member of the Township Committee was sworn into office by David A. Zeck, Sr., Upper Pittsgrove Township Committee.

Meschi nominated Jack R. Cimprich for Mayor. This nomination was seconded by Bishop. There being no further nominations, a roll call vote was taken.

The Mayor opened the meeting up for public comment. Mrs. Doris Moore presented her concerns regarding safety conditions on Colson Road. The Public Works Superintendent addressed her concerns regarding requested signage along Newkirk Station Road. Mr. Foote stated the signs had been placed and stolen. They would be replaced. Mrs. Moore's concerns regarding a tree line and site areas heading from Route 77 needed to be addressed. Committeeman Bishop had photos of the site area as you approach the intersection, showing that the visibility was very good. Her last concern was regarding a dwelling that had fallen into disrepair at 22 Colson Road. The Clerk informed her that violation notices had gone out. However, the current owner was deceased and the address of record was that of a closed PO Box.

There being no additional comments from the public and no further business the meeting was adjourned to meet at the call of the Mayor and to hold a Budget Workshop.
